The DLC will help cover the travel costs for elected officials attending the National Conversation. If you register by **Friday, April 28, 2006**, the DLC will pay up to **2 nights (room and tax) at the Hyatt Regency Denver at Colorado Convention Center (National Conversation host hotel) AND airfare up to \$250**. If you register after **April 28, 2006**, the DLC will pay for either **2 nights (room and tax) at the Hyatt Regency Denver OR airfare to Denver up to \$250**. You are responsible for making all hotel and travel arrangements.

- In case payment is needed for extra charges or cancellation, you will need to provide us with your credit card number.

For Hotel Reservations:

- 1) Complete and check the hotel option on the attached registration form and fax it to the DLC at 202-544-5002.
- 2) Call the Hyatt Regency Denver at 1-800-233-1234 to book your room. Mention that you are with the DLC to obtain a special room rate of \$145 per night, plus additional taxes and fees, for the nights of July 22nd and 23rd, 2006. We encourage you to book early, as space is limited. The special DLC rate expires on June 23, 2006. Any additional nights/incidental charges will be your responsibility.

For Airfare Reservations:

- 1) Complete and check the airfare option on the attached registration form and fax it to the DLC at 202-544-5002.
- 2) Book your ticket in one of two ways:
 - a. **Call Carroll Travel**, the official travel agency of the 2006 National Conversation, at 1-800-582-3654 or 202-543-8118. Carroll Travel will charge up to \$250 of your ticket directly to the DLC Account. Please note that you will be responsible for the cost of any unused tickets after purchase.
 - b. **Purchase your own ticket**. If you purchase your own ticket, you must submit a receipt to the DLC within 90 days following the National Conversation for reimbursement of up to \$250 of the price of the ticket
