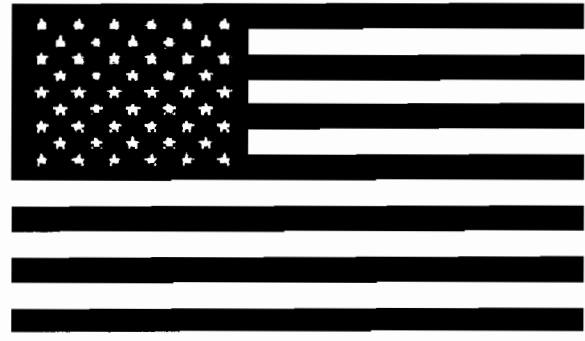
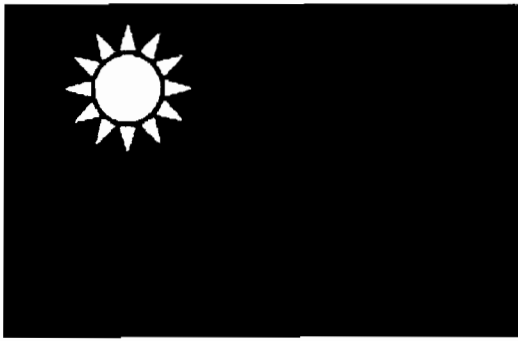
The information listed below is based upon estimates given by Scott Lai, Director of Division of Economic and Cultural Office.
