### **Networking Event**

Join your fellow members at the *Strawbery Banke Museum*, illustrating the lives of historic New Englanders with restored homes from four centuries, and featuring working artisans. Named after the earliest Portsmouth settlement, the Strawberry Banke Museum grounds are 9.5 acres of buildings from four centuries displayed as living history. Each building shows a "slice of life" from a bygone era, and serious archeological and crafts work continues to be done by staff and artisans on the museum grounds.

The Strawberry Banke Museum began in the late-1950's as a "save our history" effort by the citizens of Portsmouth. Puddle Dock, an area of dilapidated homes - some dating back to the 1600's! - near the Piscataqua River, was targeted for urban renewal. . . they were scheduled to be torn down and replaced with "modern" buildings. And while Puddle Dock did undergo a renewal of sorts, much of it has been saved as a historic museum area.

Strawbery Banke is about connecting with the past. Visitors to Strawberry Banke have the opportunity to experience and imagine how people lived and worked in this typical American neighborhood throughout four centuries of history. Through its restored houses, featured exhibits, historic landscapes and gardens, and interpretive programs, Strawberry Banke tells the stories of the many generations who settled in the Portsmouth community from the late 17th to the mid-20th centuries.
