REQUESTED ACTION

Authorize the Department of Education to pay the College Board, GPO, PO Box 27392, New York, NY 10087-7392 (Vendor Code 164060) for fee reduction waivers on Advanced Placement exams taken in New Hampshire by eligible low-income students in the amount of \$25,334.00 from the date of Governor and Council approval to June 30, 2013. This payment is retroactive for a FY12 invoice. The source of funds is 100% federal.

This is a Sole Source request. Advanced Placement exams are administered by the College Board only. This request involves fee reductions on those AP exams, and thus can only be obtained through the College Board. This request is based on 478 AP exams taken by income eligible NH students in May 2012.


The Grant Award Notification for this program was not received until August 7, 2012. This document would usually be received in March. This culminated a series of delays in federal handling of the grant. First, Congress cut the appropriation. This caused USDOE to delay- the application usually due from NHDOE in December was not due until April (one month before the AP exams). At first, USDOE stipulated a \$15 co-pay for the first three exams, and no aid beyond three. This stipulation was removed less than a month before the exam period. The NHDOE application was based on last year's total participation: 417 AP waivers plus 8 IB waivers. This turned out to be inadequate, but that was not clear until the arrival of the Grant Award Notification in August.

NHDOE has participated in the federal AP Test Fee Program grant since 2000. Through this program, test fees are reduced for qualifying low-income public and private high school students who are eligible for advanced placement testing offered through the College Board and the International Baccalaureate Organization. This opportunity is funded through the federal AP Test Fee Payment Program for low-income students. This program is authorized by the Elementary and Secondary Education Act, Title I Part G. Awards may be used only to support AP- type test fees for low-income students. Fees for AP tests administered by the College Board and the International Baccalaureate Organization (IBO) are covered. The secretary of education may approve other advanced placement tests.

The USDOE makes awards to State educational agencies to enable them to cover part or all of the cost of test fees of low-income students who are enrolled in an Advanced Placement class and plan to take an Advanced Placement test. Funds from the Advanced Placement Test Fee program subsidize test fees for low-income students to encourage them to take Advanced Placement tests and obtain college credit for high school courses, reducing the time and cost required to complete a postsecondary degree. In determining the amount of the grant awarded to a State for a fiscal year, the Secretary considers the number of children eligible to be counted under the ESEA Title I Basic Grants programs.

In the event Federal Funds no longer become available, General Funds will not be requested to support this program.
