**ASSENTED-TO MOTION FOR EXTENSION OF TIME
FOR PARTIES TO FILE WITNESS AND EXHIBIT LISTS**

NOW COME Local Government Center, Inc. and its affiliated entities, by and through their attorneys, Preti Flaherty, PLLP, and submit this Assented-to Motion for Extension of Time for Parties to File Witness and Exhibit Lists as follows:

1. On December 30, 2011, Presiding Officer Donald Mitchell ordered that each Party's final witness list and final exhibit list were to be filed on or before March 29, 2012.
2. The Parties jointly request that the deadline for filing final witness and exhibit lists be extended to no later than April 13, 2012.

3. The Parties respectfully make this request based on scheduling issues. Certain depositions are scheduled to take place during the first and potentially second weeks of April 2012.
