ARTICLES OF DISSOLUTION  
PURSUANT TO SECTION 93 OF THE  
NEW HAMPSHIRE BUSINESS CORPORATION ACT OF

PURSUANT TO THE PROVISIONS OF SECTION 93 OF THE NEW HAMPSHIRE BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THE FOLLOWING ARTICLES OF DISSOLUTION FOR THE PURPOSE OF DISSOLVING THE CORPORATION:

FIRST: The name of the corporation is Electric Software, Inc.

SECOND: A statement of intent to dissolve the corporation was filed by the Secretary of State of New Hampshire on April 3, 1985, pursuant to the provisions of Section 86 of the New Hampshire Business Corporation Act.

THIRD: All debts, obligations and liabilities of the corporation have been paid and discharged, or adequate provision has been made therefor.

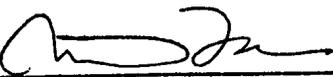
FOURTH: All remaining property and assets of the corporation have been distributed among its shareholders, in accordance with their respective rights and interests.

FIFTH: There are no suits pending against the corporation in any court in respect of which adequate provision has not been made for the satisfaction of any judgment, order or decree which may be entered against it.

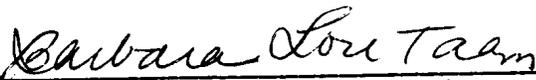
SIXTH: A statement is attached from the New Hampshire Department of Revenue Administration that all taxes due from or accrued by the corporation through the date of the articles of dissolution have been either assessed and paid, or adequately provided for in a manner acceptable to the New Hampshire Department of Revenue Administration.
