#### STATEMENT NUMBER

**FIFTH:** If the name of the limited liability company does not contain the words "Limited Liability Company" or the abbreviation "L.L.C.", insert the name of the limited liability company with the words "limited liability company", the abbreviation "L.L.C." or similar abbreviation.

#### **OR**

If a professional limited liability company, RSA 304-D:6 requires the name shall end in "Professional Limited Liability Company" or the abbreviation "P.L.L.C."

#### **OR**

If the limited liability company name is not available for use in New Hampshire, enter the name to be used in New Hampshire. In this case a trade name application must be filed with an additional \$50.00 fee (a limited liability company designation cannot be used on the trade name). If the limited liability company name is available and a trade name is to be registered in addition to the limited liability company name, do not enter the trade name in this space but DO file a trade name application with the \$50.00 fee.
